I agree to not consume alcohol prior to playing Zorb Football, I also agree not to ingest any medicines or substances that will inhibit my mental or physical ability to safely and effectively participate in the game. I agree to abide by any decision of a Zorb Football UK staff member relative to my ability to safely play. I agree to obey all civil and criminal laws at all times. I assume all risks associated with playing Zorb Football, including but not limited to falls, contact with other participants, negligent or wonton acts of other participants, defects or condition of premises, the effects of the weather, including high heat and/or humidity and or heavy rain, all such risks being known and appreciated by me. I agree that the chosen venue/location is not responsible for any personal items or property that are lost or stolen on site. I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to me as medical professionals may deem appropriate. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency. I grant permission to Zorb Football UK, its affiliates, sponsors and assigns to use any photographs, motion pictures, recordings or other records of the event that are the sole property of Zorb Football UK. I understand that all entries are final with no refunds. Participants are expected to exhibit appropriate behavior at all times, including obeying all laws. This includes respect for all people, equipment, and facilities, and cooperative, positive participation. Zorb Football UK may dismiss, without refund, anyone whose behavior endangers the safety or negatively endangers safety or negatively affects a game, a person, a facility, or property of any type or kind. I also agree to indemnify Zorb Football UK, it's affiliates and assigns, from any and all third party claims caused in whole or in part by my actions. I agree that I am 16 years old or older, or my parent/guardian has reviewed this waiver and consented to its terms. Waiver & Release of all claims & assumption of risk. I recognize and acknowledge that there are certain risks of physical injury to participants during a game of Zorb Football, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I am solely responsible for determining if I or my minor child/ward is physically fit and/or skilled for the race or activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant or disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity. I do hereby fully release and forever discharge Zorb Football UK form any and all claims for injuries, damages or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with these programs/activities. I have read and fully understand the above important information, warning of risk, assumption of risk and waiver to release of all claims.

IF YOU ARE A PARENT OR GUARDIAN OF A PARTICIPANT UNDER THE AGE OF 16: I, the parent or guardian of the minor I am purchasing a ticket for, hereby give my approval to this child's participation in the activities. I assume all risks and hazards incidental to such participation in a Zorb Football game, and I hereby waive, release, absolve, indemnify, and agree to hold Zorb Football UK, its officers, heirs, assigns, administrators, personal representatives and executors, firms, corporations, business, and governments, and all sponsors, their representatives and successors and other persons, for any claim arising or of an injury to my/our child and from any and all claims, causes of actions, obligations, lawsuits, charges, complaints, contracts, controversies, covenants, agreements, promises, damages, costs, expenses, responsibilities, of whatsoever kind, nature or description, where, direct or indirect, in law or in equity, in contract or in tort, or otherwise, whether known or unknown, from all claims or liabilities of any kind arising out of or connected with my child(ren)'s participation in this event. I consent to the foregoing and grant my permission for him/her to participate in the Zorb Football game.
